### INCREASE IN LEVY IN RESPECT OF DISPUTE RESOLUTION COLLECTIVE AGREEMENT

On the 21 July 2017, the Management Committee (Manco) adopted the Dispute Resolution Collective Agreement.

The parties to this agreement are all SEIFSA-affiliated Employer Associations, Neasa, Saefa, CEO, PCA and Trade Unions, National Union of Metalworkers of South African (NUMSA), Solidarity, United Association of South Africa (UASA- The union) Metal and Electrical Workers Union and SA Equity Worker's Association (SAEWA).

In terms of the agreement the levy increased with effect from the 21 July 2017 as follows:

R0.71 per week per employee with the employer making a matching contribution.

or

R3.07 per month per employee with the employer making a matching contribution.

In clause 5(2)(c) of the collective agreement provision is made for these levies to further increase in the second and third year by the respective year on year inflation rate as at December of the previous year.

The year on year inflation rate as determined by Stats SA for December 2017 was 4.7%.

In terms of the above the dispute levy will increase with effect from 1 August 2018 as follows:

R0.74 per week per employee with the employer making a matching contribution  
(previously R0.71).


or

R3.22 per month per employee with the employer making a matching contribution  
(previously R 3.07).

The increase is binding on all employees (scheduled and non-scheduled )who are members of any of the Trade Unions listed above and employers who are members of the SEIFSA- affiliated Employer Associations, Neasa, Saefa , CEO, and PCA .
